CONDITIONS OF SUPPLY

1. The water (undertaker) Rules, and the water (Water Development Department General) Regulations (Sub. Leg. L.N. 74/1962) as from time to time amended, shall be deemed to be incorporated in and to form part of these conditions of supply.
2. Applications for execution of works will, as a rule, be dealt with in order of priority of date, but the water undertaker reserves the right of executing the work in the manner and at the time best suited to his convenience.
3. All charges shall be payable on demand.
4. If any account is overdue the water supply may be cut- off under the provision on the water (undertakers rules, (cap.372) and proceedings taken to recover the charges due.
5. Any changes in the charges shall be notified in the Gazette and in addition details thereof shall be sent to each consumer with the monthly account preceding such change.
6. The water undertaker shall have the right forthwith and without notice to terminate the agreement for any breach by the consumer of conditions of supply, but without prejudice to any antecedent right against the consumer including the right to take proceedings
7. a) No consumer shall use or permit to be used, any other supplied pursuance of an application made by claims under regulation of these regulations except for such use as specified by him in his application.
b) No consumer shall convey or permit to be conveyed by any means whatever, for use outside, his plot, or for sale, any water supplied to him by the water undertaker.
8. In accordance with regulation 12 of those regulations, the consumer shall deposit Ksh which shall be retained by the water undertaker for the period during which the consumer is supplied with water.
9. The consumer shall meet all charges in respect of water supplied in pursuance of this application and consumers agreement until such time as the supply is disconnected to a written request made by him.
10. After the supply disconnection for the failure to honour rule 3 the connection shall be Ksh 500.
(Reconnection Fee)
11. That if the undertaker identifies an illegal connection the penalty is not less than Ksh 5,000.
12. Tempering with company's hydraulic assets calls for a fine not less than Ksh 5,000. Or termination of water supply for a period not more than 6 Months or both.
